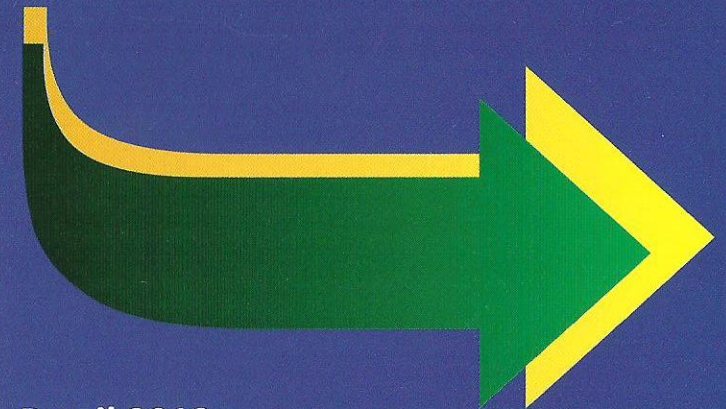

# Foreigner Convicted in Brazil

## WHAT DOES THE TRANSFER MEAN?

It's the prerogative that a convicted foreigner has to serve the rest of the sentenced imposed by the Brazilian Justice in his country of nationality.

## WHAT ARE THE OBJECTIVES OF THE TRANSFER?

As a human right institute, it has the aim of providing social rehabilitation, approaching the convicted person to his family and social and cultural environment.

## AFTER SERVING THE SENTENCE, CAN THE FOREIGNER RETURN TO BRAZIL?

No. The foreigner convicted by the Brazilian Justice, when transferred, will be expelled from Brazil and is impeded from returning to the country, according to the Brazilian Penal Code.

## HOW DOES THE TRANSFER PROCESS WORK?

**1.** The requirement is free of charge and does not need the assistance of a lawyer.

**2.** The convicted person must personally request the transfer. The person can use the form that is in the back of this brochure as a model.

**3.** The process will be instructed by the Foreigners Department of the National Secretariat of Justice of the Ministry of Justice.

**4.** When the transfer of the convicted person is approved by Brazil and by the country of origin, the measure will be carried out.
